MACO (and/or 2016 OCEAN ACTION PLAN) GOALS, OBJECTIVES and ACTIONS:

Mid-Atlantic Committee on the Ocean (MACO)

MACO's Non-Consumptive Recreation working group is conducting activities in continuation and support of the 2016 Mid-Atlantic Ocean Action Plan's Section 2.4.7: *Non-Consumptive Recreation*, Objective 7, which states, "Account for the importance of nearshore and offshore non-consumptive recreational uses, and their local and regional economic contributions in the Mid-Atlantic; and in the management of other ocean uses and resources, consider impacts on non-consumptive recreational activities (e.g., surfing, boating, whale watching, birding, diving)."

ACTIVITY 1 - Finalize the development of a compiled database of states' public recommendations for reducing or avoiding human-wildlife interactions during non-consumptive recreational activities.

A1 Progress Description

The work group has reviewed and made recommendations to the database on multiple occasions, and an internal version is near completion. The workgroup has added information from various sources, beyond the existing State information, such as NOAA's Ocean Etiquette information. The database will be formatted for public viewing and posted to the Non-Consumptive Recreation webpage on MARCO's website when it is finalized.

ACTIVITY 2 - Develop a whitepaper that synthesizes recommendations within the database (Activity 1), and recommends regional best practices for minimizing human-wildlife interactions during nonconsumptive recreational activities.

Progress Description

Post 2020 Mid-Atlantic Ocean Forum workgroup membership was expanded to move the effort beyond the OAP identified actions. The intent will be to further expand on issues identified at the Ocean Forum and through workgroup discussions, such as:

- Examine updating the recreational survey data on the portal with partners
- Incorporate/expand recreational related GIS work,
- Investigate development of a user facing app with mapping/reporting capabilities
- Examine the economic importance of tourism and the recreational use economy,
- Examine developing best practices for whale watching with the increase of juvenile humpbacks in the nearshore and the possibility of a certification program
